



DATA PROTECTION MANDATORY CONSENT FORM

Under the EU General Data Protection Regulations (GDPR) we, Seacourt Tennis Club Ltd, need (a) to obtain your consent to us continuing to hold your personal data and (b) to inform you of your individual rights under the GDPR.

Seacourt Tennis Club Ltd currently holds an amount of personal data on you, including your name, address, email address (if supplied to us) telephone numbers, date of birth, occupation, gender, Real Tennis handicap, some subscription information, Seacourt card account balance and bank details for the sole purpose of collecting subscriptions by standing order or direct debit (if you are a direct debit member).

To enable Seacourt Tennis Club Ltd to continue to function effectively we need to be able to communicate with Members. Seacourt Tennis Club Ltd will still be able to communicate with you without your consent if it is required to carry out the business of Seacourt Tennis Club Ltd (such as notification of subscription rates or increase in court fees), but otherwise Seacourt Tennis Club Ltd will NOT be able to communicate with you using the data it holds UNLESS YOU GIVE YOUR CONSENT.

We set out below the various ways in which Seacourt Tennis Club Ltd would like to collect, store and use (process) your personal data. You are now asked to GIVE YOUR CONSENT to each of those processing items which is acceptable to you BY PLACING X IN THE BOX below each such item:-

1. Email - Seacourt Tennis Club Ltd uses email as the main means of communication with Members. If you do not place X in BOX 1, Seacourt Tennis Club Ltd will not be able to send you any further emails. This will greatly reduce your access to information from Seacourt Tennis Club Ltd.

2. Post - Seacourt Tennis Club Ltd occasionally sends information to Members by post and wishes to have the ability to communicate with its Members by post. Even if you do not place X in BOX 2, Seacourt Tennis Club Ltd will legally be able to send you notice of any increase in subscription rates and any increase in court fees.

3. Telephone (landline number) - Seacourt Tennis Club Ltd needs to contact Members by telephone from time to time. If you do not place X in BOX 3, Seacourt Tennis Club Ltd will not be able to contact you by telephone.

4. Telephone (mobile number) - As per item 3 Telephone (landline number).

5. Seacourt Tennis Club Ltd may also share your information with its Professional Coaches, Administrative Staff and Bar and Catering Staff.

6. Seacourt Tennis Club Ltd wishes to use your personal data for any other legitimate use for the purposes of its business and to further the Sports, Fitness and Social Events amongst its Members.

7. Photographs – Occasionally Seacourt Tennis Club Ltd will place photographs of Members in action at sports and social events on its website and Facebook page.
