

## RISK ASSESSMENT FORM

<b>ACTIVITY AND LOCATION:</b> Provision of Squash Court F to Jon Barnes for Golf Coaching during Covid 19 restrictions. This is a joint risk assessment: the first part by Seacourt for the provision of the space, the second part by Jon Barnes for the provision of golf coaching.			
<b>DETAILS OF THE HAZARD(S) IDENTIFIED:</b> Contact with the Covid 19 virus. Contact and airborne Impact from golf balls and golf clubs			
<b>PEOPLE AT RISK:</b> Golf Coach Participants in the activity Seacourt staff on duty			
<b>PRECAUTIONS ALREADY TAKEN TO REDUCE THE RISK:</b>  <b>1. Seacourt space provision:</b> As the space is locked up, Jon will undertake general cleaning of the space to keep it clean and tidy. Doors in the area will remain wedged open to ensure good airflow around F court. All windows will be open (Sports hall and gallery above). Air quality will be monitored on a regular basis and recorded. Only 2 people, the instructor and pupil permitted to occupy the room. If working solo with minors, a valid DBS (Disclosure & Barring Service) check must be made. If not, a parent may attend at the gallery above the court. Access will be via the west side fire exit adjacent to F Court with a requirement to use the sanitizer on arrival and leaving. Toilets at the front (north) of the building may be used. No access to changing or shower facilities. There will be a minimum of 15 minutes between bookings of the court during which time it will remain vacant to allow change of air and avoid congestion. No access to the bar or terrace for refreshment unless previously booked.			
<b>2. Jon Barnes provision of golf coaching:</b> Ensure participants arrive only if they are feeling well and no members of their household are unwell. At time of booking, participants briefed on arrival procedure and access point, social distancing and hygiene protocols (using sanitizer at the door), including provision of own sanitizers and abiding by the club rules and requirements for good hygiene. Prompt arrival and departure requirements (no gathering anywhere on club premises for socialising) Clients will arrive ready-dressed for the activity - no use of club changing rooms, minimum possessions - own clubs, keys and drinks. Clients will not be allowed to touch golf balls. Social distancing to be maintained throughout the session. Other hazards: Impact from golf balls. The pre-tensioned screen at the front of the booth is designed to absorb the force of the ball so there is no rebound. Impact from club. Professional training establishes competence to avoid impact for Professional and pupil. High level of noise level from driver contact with ball. Booth totally lined with sound-absorbing tiles.
